About 70 persons were present, it was a real success and interesting session.

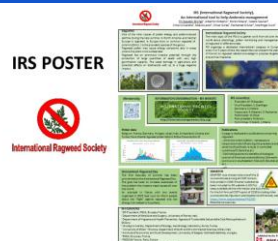
